IMPORTANT: Changes to National Minimum Wage

As you may know every October, the National Minimum Wage changes.

Below are the new rates from October 1st 2014 onwards:

£6.50 the main rate for workers aged 21 and over (19p rise)

£5.13 the rate for 18/20 year olds (10p rise)

£3.79 the rate for 16/17 years olds who are working above school leaving age but under 18 (7p rise)

£2.73 the apprentice rate – for apprentices under 19, or 19 and over and in the first year of their apprenticeship (5p rise).
